HUD PROGRAMS

Public Housing: Provides apartment units or houses to individuals and families who meet eligibility requirements for assistance. Approved individuals and families pay 30% of their adjusted income toward the rent. There is usually a waiting list. Call Columbus Housing Authority, 799 McClure Rd., (812) 378-0005 to apply.

Section 8 - within 5 miles of city limits: Provides vouchers which allow families who meet eligibility requirements to choose an apartment or house to rent from an approved landlord in the private rental market. Approved individuals and families pay a percentage of their income toward the rent, and the HUD agency pays the balance of the "fair market rent" to the landlord or apartment complex. There is usually a waiting list. Call Columbus Housing Authority, 799 McClure Rd., (812) 378-0005 to apply.

Section 8 - outside 5 mile radius of city limits: Provides certificates which allow families who meet eligibility requirements to choose an apartment or house to rent from an approved landlord in the private rental market 5 miles outside city limits. Approved individuals and families pay a percentage of their income toward the rent (usually 30%), and the HUD agency pays the balance of the "fair market rent" to the landlord. There is usually a waiting list. Call Human Services, Inc., 4355 E 600 N., (812) 372-8407 to apply.

FINANCIAL ASSISTANCE

Township Trustee Vouchers: Persons must apply for assistance through the Trustee of their residence first. Eligible persons may receive assistance with current rent or utilities (Not deposits, late rent, or first months rent in some cases). Love Chapel Vouchers: Persons may apply for assistance with rent, deposits, or utilities after checking with their Township Trustee (if applicable). Call (812) 372-9421 (Mon-Fri 9am-11am).

STEP BY STEP RENTING INSTRUCTIONS

- 1. Persons seeking housing should check newspapers, phone book, trailer parks, realtors, and rental signs in addition to the information on this Housing List.
- 2. Renters should contact apartments, landlords, and the Housing Authority to check availability.
- Find out all rental costs.
- 4. Request any needed financial assistance from Trustee, Love Chapel, HUD, and Section 8.
- 5. Once the person inspects the property to be rented, he/she should make note of any defects that are already present.
- 6. Read the lease and understand it before it is signed. A lease is a legal contract that offers protections to both renter and landlord.

HOMELESS SHELTERS - Homeless persons are encouraged to seek out shelter with family and friends first.

Brighter Days Housing is the point of entry for homeless individuals. Call (812) 344-4512 for assessment.

Horizon House is the point of entry for homeless families with children. Call (812) 799-1062 for assessment.
